

PLAYING FIELD COMMITTEE – COMMITTEE MEETING 30th NOVEMBER 2010 - 7.30PM AT PAVILION

MINUTES OF LAST MEETING 5TH OCTOBER 2010 TAKEN AS PRESENTED AND APPROVED.

MATTERS ARISING

ENERGY AUDIT – NO RESULTS RECEIVED FROM LDC

PERCY'S PATCH – WAITING TILL SPRING TO CARRY ON WITH PLANNED WORK.

WATER BILLS – TENNIS CLUB, TERRY BEEN IN CONTACT WITH GARETH PROSSER CHAIRMAN OF CLUB. THEY SUGGEST A PAYMENT OF £150 AND HAVE FIGURES TO PROVE IT. IT WAS AGREED BY THE MEETING TO ACCEPT THIS OFFER AND TERRY TO RAISE INVOICE. THE TENNIS CLUB HAVE AGREED TO PAY FOR THE COST OF THE INSTALLATION OF A PRIVATE METER AND PAY THE CHARGE FOR ANY FUTURE WATER USED. KELVIN SUGGESTED THAT WHEN THE LEASE IS UP FOR RENEWAL THAT THE PARISH COUNCIL CONSIDER A MORE ECONOMIC CHARGE BE MADE FOR THE CLUBS FACILITIES.

SKATE BOARD PARK NOTHING TO REPORT.

ELECTRICAL INSPECTION. PROTECTION TO EARTHING CABLE ON NORTH SIDE OF PAVILION – TT STILL TO DEAL WITH. KELVIN REPORTED AN ISOLATED PROBLEM WITH THE BAR POWER SUPPLY AND MEG REPORTED AN ISOLATED PROBLEM WITH THE WHOLE POWER SUPPLY. TERRY ASKED IF ANY FURTHER PROBLEMS TO LET HIM KNOW SO THAT IT CAN BE LOOKED INTO.

CLEANING – SARAH DOING A GOOD JOB.

REPAIRS – CHANGING ROOM WINDOW PANE REPLACED. GUTTERS ON REAR OVERHANG ROOF NEED ATTENTION – TT STILL TO DEAL WITH THIS INSPECTION CHAMBER COVER AND FRAME NEEDS ATTENTION IN CAR PARK – IAN DEALING WITH THIS. AND SHOULD BE DONE BY END OF YEAR. FENCE ADJACENT TO THE ENTRANCE TO THE PAVILION HAS BEEN DAMAGED – TT TO ASK DAVID WESTGATE TO REPAIR.

RECYCLING – VAP LOOKING INTO POSSIBILITY OF BOTTLE BINS

ESTIMATES FOR 2011-2012_ STANDARD ITEMS AS PER PREVIOUS YEARS PLUS POSSIBLE COSTS FOR THE FOLLOWING:-

GATES ADJACENT TO THE SKATE BOARD PARK MAIN ENTRANCE TO PAVILION REPLACING 3NO EXTERNAL DOORS

STABILISE THE FOOTBALL PITCH - NOTHING TO REPORT.

FUN DAY – DATE CHANGED TO 10TH JULY 2011.

DAMAGE DURING A PRIVATE HIRING - A WINDOW IN THE MAIN HALL WAS BROKEN AND DOORS RIPPED OFF EXTERNAL SHED AND HONEYBEES TOASTER RUINED. CLARE HAS SPOKEN TO THE HIRER AND HE HAD AGREED TO MAKE A DONATION TO HONEYBEES – THIS HAS NOT BEEN RECEIVED. IT WAS AGREED TERRY WOULD WRITE TO THE HIRER EXPRESSING THE COM. CONCERNS. KELVIN REPORTED THAT THE SHED WOULD BE REMOVED IN SPRING.

STOOLBALL MATCHES 12TH AND 19TH SEPTEMBER 2011 WHEN THE JUNIOR FOOTBALL CLUB WOULD BE UNABLE TO USE THE PLAYING FIELD ETC – CLARE TO LIASE WITH PAUL.

NEW PAVILION KELVIN HAS TAKEN OVER AS CHAIRMAN OF VAP FACILITIES TEAM. HE REPORTED THAT A MEETING BEING HELD NEXT MONDAY WITH USERS TO FINALISE IDEAS. IT WAS HOPED TO HAVE SOMETHING TO SUBMIT TO THE PARISH COUNCIL IN EARLY FEBRUARY 2011. IT IS LIKELY AT LEAST 2 OPTIONS BASED ON EVERYBODIES “WANT LISTS”. TERRY EXPRESSED CONCERN THAT THE PROGRAMME THAT JAMES HAS PREPARED MAKES NO MENTION OR TIME FOR RAISING THE FUNDS AND THAT THIS IS AN EXTREMELY IMPORTANT ELEMENT. KELVIN TO TAKE THIS UP WITH JAMES AND IS AWARE OF THE IMPORTANCE. IT WAS DISCUSSED THAT IT MIGHT BE WORTH CONSIDERING PROVIDING PUBLIC TOILETS IN THE NEW PAVILION ESPECIALLY AS CLOSE TO SDNP.

JO ASKED THAT STOOL BALL WANT A NICE KITCHEN AND POSSIBLE ADDITIONAL LADIES TOILET

PLAY AREA KELVIN HAD NOTHING TO REPORT. THE PFC CONCERNED THAT MOMENTUM IS NOT LOST ON THIS ITEM AND KELVIN SAID HE WILL HAVE A BETTER IDEA IN A COUPLE OF WEEKS. THE PFC WOULD BE HAPPY TO TAKE THIS PROJECT BACK “IN HOUSE” AS CLARE HAD DONE A LOT OF WORK ON IT PREVIOUSLY. THE TYPE OF PLAY AREA IE ECO FRIENDLY OR OTHER WAS ALSO DISCUSSED AND IT WAS SUGGESTED THAT SCHEMES FOR BOTH TYPES BE DRAWN UP AND COSTED SO THAT THE OPTIONS COULD BE GIVEN TO THE VILLAGE. THE 106 MONEY IS TO BE SPENT BY 2014.
